# Announcement of a Press Conference of the 16<sup>th</sup> EU-Japan Business Round Table on 9 April at 12:30 at the Imperial Hotel Tokyo

Tokyo, 1 April 2014

The EU-Japan Business Round Table (BRT), a forum of around 50 European and Japanese business leaders, will hold its 16<sup>th</sup> Annual Meeting in Tokyo on 8 & 9 April 2014, co-chaired by Messrs Fabrice Brégier (President & CEO of Airbus S.A.S.) and Hiromasa Yonekura (Chairman & CEO of Sumitomo Chemical Co., Ltd.).

Under the theme of "EU-Japan Cooperation – New Opportunities for Global Growth", the annual meeting will discuss the ongoing negotiations of the EU-Japan Free Trade Agreement (FTA)/Economic Partnership Agreement (EPA), new industrial revolution toward sustainability, and major business themes for the EU and Japan in the post FTA/EPA.
