 - To promote measures to achieve a “Decarbonised Society” with “Sustainable Economic Growth”
 - To strengthen economic security and competitiveness in the environmental and energy sectors.
 - To promote the construction of resilient and reliable global supply chains for clean energy and decarbonisation that address strategic dependencies and structural vulnerabilities.

- **WP-4/#02*/EJ to EJ : Use Regulation to Improve Quality Of Life and Environment But Prevent Regulation From Stifling Innovation and Progress**
 - To make regulations simpler better, and internationally harmonised
 - To avoid unnecessary burdens to industry, and prevention of necessary innovation and progress.

- **WP-4/#03*/EJ to EJ : Promotion of Resource Efficiency and the Circular Economy**
 - To pursue resource efficiency and circular economy not only from environmental aspects but from viewpoint of creation of business opportunities, promoting economic autonomy and potential to strengthen competitiveness.
 - To support development of technologies and products to reduce usage of indispensable critical minerals, which also contribute to securing economic security.
- **WP-4/#05*/EJ to EJ : Realization of a Resilient and Comfortable Life**
 - To take necessary measures to strengthen cybersecurity of critical infrastructure such as energy-related infrastructure to prevent serious accidents.
 - To promote adaptation finance, which allocates funds to efforts to respond to visualised climate risks in advance.
