#### APPLY FOR “KEYS TO JAPAN”

“KEYS TO JAPAN” is a European Commission-funded support initiative, managed by the EU-Japan Centre to help selected SMEs considering marketing a product or service in Japan, which will **sponsor the production of a detailed and comprehensive Japan market entry/expansion plan** for them. SMEs must be based in the EU or in SMP-COSME Third Countries\*.

#### OBJECTIVES

- Open new doors in Japan - develop and expand the spectrum of business opportunities in Japan for EU/SMP-COSME based SMEs, finding tailor-made approaches, in particular to overcome the Covid19 slow-down of trade.
- Help EU/SMP-COSME based SMEs identify a winning market entry approach and offer practical tools and a route to strategy implementation

#### WHO CAN APPLY

The support is dedicated to Small & Medium Sized enterprises (SMEs), based in the EU or in SMP-COSME Third Countries\*.

- Mid-late September 2023: Selection of **2 winning proposals**
- Market research and business plan preparation by JMEC: from January to May 2024
- Final business plan delivery: **May 2024**
